## Privacy Policy

### I. Introduction

In Dyut Foundation we are committed to protect the privacy and personal information of our donors, beneficiaries, volunteers, partners, and visitors. This Privacy Policy explains how we collect, use, disclose, and safeguard your information when you interact with us through our website, offline initiatives, events, and programs.

### II. Information we collect

We may collect the following types of personal and non-personal information:

- Personal Information: Name, address, email address, phone number, date of birth, gender, or any other details you voluntarily provide when you donate, volunteer, register for programs, or contact us.
- Financial Information: Bank account details, payment card information, or transaction details, PAN Card details (only when you make a donation or payment).
- Program-Related Information: Details related to beneficiaries, participants, or stakeholders in our child education, environmental, or livelihood initiatives (e.g., school enrollment data, occupation, or socio-economic status).
- Digital Information: IP address, browser type, device information, and cookies when you visit our website.
- Financial Information: Bank account details, payment card information, or transaction details, PAN Card details (only when you make a donation or payment).
- Program-Related Information: Details related to beneficiaries, participants, or stakeholders in our child education, environmental, or livelihood initiatives (e.g., school enrollment data, occupation, or socio-economic status).
- Digital Information: IP address, browser type, device information, and cookies when you visit our website.
- Photographs and Media: Images, videos, or testimonials collected during events or programs, with your consent.
- Other Information: Any additional data you provide through surveys, feedback forms, or communications to Dyut Foundation.

### III. How we collect the information

- **Site Browsing:** Our site can be browsed anonymously. We do not require you to identify yourself or reveal any Personal Information while browsing through the Site. However, you may not be able to access certain sections of the Site or interact with us without providing the Personal Information. For instance, you would not be able to transact at the Site or make any donations at the Site, without providing the Personal Information. If you desire to register yourself at the Site, you would be required to provide your Personal Information.
- While you are browsing the Site, the website may automatically record some general information (“General Information”) about your visit such as Date and time of your visit to the Site, along with the address of the previous website you were visiting, if you were linked to us through another website, type of browser you are using (such as Internet Explorer version ‘X’), Type of ‘hit’ made to the server to request a response:
  - The General Information is NOT Personal Information. Dyut Foundation tracking system does not record personal information about individuals or link this information to any Personal information collected from you.
  - The General Information is used by Dyut Foundation for statistical analysis, for tracking overall traffic patterns on the Site and to understand the public interest in Dyut Foundation activities. Such General Information may be shared by Dyut Foundation with any person at Dyut Foundation’s sole and exclusive discretion.
- **Cookies:** “Cookies” are small amounts of data that a website can send to a web browser on a visitor’s computer. The cookie is stored on a visitor’s computer. A cookie may enable the site holder to track how a visitor navigates through its site and the areas in which the visitor shows interest. It tracks trends and behaviours, but does not identify individuals. Information gathered may include date and time of visits, pages viewed, time spent at the site, and the site visited just before and just after the Dyut Foundation site.
  1. Refusing Cookies on Dyut Foundation’s Website: Visitors may choose not to accept cookies. Your web browser may alert and permit you to refuse cookies. When you receive an alert, you may choose at that time to refuse that cookie. If the use of cookies is a concern to you, then please make sure your browser has this capability, and that you set your browser to alert you accordingly. Newer browser versions allow you to be alerted or to automatically refuse cookies. You may need to download a more current version of your web browser from your service provider in order to obtain this option.
  2. Some website features and services provided by Dyut Foundation require you to accept a cookie in order to be able to use the particular functionality or service. These cookies are used to establish a link between the user and the application server. The cookies contain unique session IDs, and no customer data is stored on the cookies.

We do not sell, rent or trade your personal information. However, we may share in the following cases:

- With authorized service providers involved in processing donations or maintaining our systems.
- Dyut Foundation cannot guarantee that such parties will keep your Personal Information confidential and Dyut Foundation will not be liable in any manner for any loss of confidentiality attributable to such third parties.
- Dyut Foundation may share Personal Information with persons who are associated with them, including companies and non-governmental organisations affiliated with Dyut Foundation in any manner deemed fit by Dyut Foundation in its discretion. Dyut Foundation will retain ownership rights over such information and will share only such portions of the Personal Information as it deems fit.
- With media or partner organizations for impact documentation, only with prior consent
- Notwithstanding anything contained herein or any other contract between you and Dyut Foundation, Dyut Foundation reserves the exclusive right to disclose any Personal Information about you without notice or consent as may required to satisfy any requirement of any law and/or regulation and/or legal request and/or legal investigation and/or to conduct any investigation of any breach or allegation of breach of law and/or to protect the Site and/or to protect Dyut Foundation and its property or to fulfill your requests and/or to protect our visitors and/or other persons and/or if otherwise required by any policy of Dyut Foundation.

#### VI. Data Security

In Dyut Foundation we implement appropriate technical and organizational measures to secure your personal data. These include secure servers, encryption, access controls, and confidentiality agreements with third parties. However, while we strive to protect your information, no method of transmission over the Internet is completely secure.
